

# WEE BOUTIQUE CONSIGNMENT AGREEMENT



In consideration for the opportunity to participate in and profit from consigning with Wee Boutique, please read and acknowledge your acceptance of the following Terms of Agreement by initialing each section.

\_\_\_\_\_ All consigned items need to be in good condition, laundered, dustless, spot-free and folded neatly and ready to go when given to us. If time permits, we will look through your items while you wait, otherwise, we will email you your itemized intake immediately after we enter the items into inventory. We will carefully examine merchandise for tears and/or stains. If an item does not meet our standards we reserve the right not to sell that item. If this is the case, we will notify you, and give you the option to take it back, or we will donate it for you. Tax receipts for your personal tax purposes are only available if requested.

\_\_\_\_\_ We reserve the sole right to set the prices on the consigned articles. Generally, we look at comparable items, and based on condition we price accordingly. Markdowns/discounts may be taken at our discretion during the consignment period. A 50% markdown will be taken after 60 days. We reserve the right to put items on sale at times deemed necessary to move merchandise or to celebrate the end of a season or special occasions. We will get the best possible prices for you.

\_\_\_\_\_ Consignors will be paid 50% of the total sale price of their items. Consignor represents & states that he/she is the owner of all goods placed for consignment & that the goods are sale-able &/or free & clear of liens or other claims. Please bring your electronic items to us with working batteries. If we need to replace them the consignor will have an extra .50 cents per battery deducted from their account.

\_\_\_\_\_ Consignor credits may be used immediately and at any time for store purchase. Disbursements by check are paid after the 15th of every month. We will notify you by email each month if you have a \$20 credit or higher. Payment by check can be mailed only if requested. You can check your account activity and balance at anytime electronically with your personal account number. Please note a monthly convenience charge of \$1.00 will be deducted from your credit to be able to use the Consignor Access service. If you do not have any items in consignment there will be no charge.

\_\_\_\_\_ I understand that my unsold items can be either donated or picked up at the end of the 90-day consignment period. Consignors are responsible for pulling their own merchandise if they wish to pick up the remainder of their items. If they are not picked up, they become property of Wee Boutique to distribute as we see fit. **No claims for payments on consigned items may be made after 6 months from date of consignment.**

\_\_\_\_\_ Wee Boutique **does NOT** assume responsibility nor do we reimburse consignor for loss or damage due to fire, theft, or for any other reason. All risk of ownership of consigned items shall stay with the consignor. Wee Boutique does not make any warranties or representations about the safety or suitability of items consigned. We Boutique has no experience or expertise in manufacturing, repairing, or inspecting merchandise for safety, ease of use, or fitness for a particular purpose and therefore disclaims any responsibility for recalls, defective merchandise, or safe usage for any purpose. Should a client wish to close his/her account, it is understood that we receive a one-week notice. This will allow sufficient time to find and pull all of the merchandise that has not yet been sold.
